	Academic Matters
Campus in Düsseldorf – MBA Exchange Program	Since April 2013, all MBA courses have been taking place at our second Campus in Düsseldorf, which is now the center of excellence for post- experience programs offered by WHU.
	Full-time and Part-time MBA courses for exchange students are held on our campus in Düsseldorf, while Master in Finance (MSc), Master in Management (MSc), and Bachelor in International Business Administration (BSc) courses still remain in Vallendar, as will the European Summer Institutes.
	Graduate students fulfilling the WHU MBA admission requirements (see below) need to decide prior to nomination which program they would like to join. The partner universities should include in their nomination email whether the nominated graduate student will join our MSc (Vallendar) or MBA (Düsseldorf) exchange program.

Language of Instruction	Two undergraduate tracks are offered: either with 80% percent or 100% of the courses in English. The graduate programs are completely taught in English.	
Language Requirements	BSc and MSc exchange students do not need to prove their proficiency in English as we trust the selection process of our partner universities. However, a high level of English proficiency is required as the majority of the courses are taught and examined in English. We therefore strongly recommend that exchange students have English language skills equivalent to an internet based TOEFL score of at least 95.

Nomination Procedure	The home university nominates their student(s) via email including the following information:
	<ul> <li>First name and family name of the student</li> <li>Student's gender</li> <li>Student's nationality (for visa purposes)</li> <li>Term(s)</li> <li>Study program (BSc, MSc)*</li> <li>Student's email address</li> </ul>
	* Due to the different campus locations and program structures, graduate exchange students can no longer mix MSc and MBA courses.
	From now on, the <u>partner university should indicate for each nominee</u> <u>upon nomination whether this graduate student is applying for our MSc</u> <u>Exchange Program on our Vallendar campus (see our WHU Campus</u> <u>Vallendar BSc MSc Fact Sheet) or our MBA Exchange Program on our</u> <u>Düsseldorf Campus (if eligible).</u>
Application Process	After the home university has emailed the nomination to the respective exchange coordinator at WHU, the nominated student(s) will receive instructions for the <u>online application</u> procedure via email.
	Shortly after the application deadline, we will process the complete online applications and send an acceptance package including the letter of acceptance for each student to the international office at the home university.

	The application for housing is done within the online application. After processing the application the housing office will contact the students directly. Housing is distributed on a <i>first-come, first-served basis</i> . Exchange students will be given support to find their apartment before arrival, either by maps, detailed descriptions on how to find the apartment or by a WHU student buddy. <u>Expected date of arrival</u> : the day before our mandatory orientation.

	Depending on their nationality, students might need a visa and/or residence permit to study in Germany. While we assist students in applying for their residence permit during orientation, it is the student's own responsibility to take care of visa matters as early as possible, ideally at least 2 months prior to departure.
	Students should contact the German Consulate of their home country (or country of residence) to find out if they need a student visa prior to entering Germany/Europe for study purposes.
Health Insurance	<u>www.whu.edu/exchange</u> > Campus Vallendar > Arrival at WHU > Health Insurance
	<ul> <li>All exchange students have to provide proof of health insurance upon their arrival at WHU. It has to cover the following aspects to be acknowledged by the German authorities:</li> <li>Period of time: coverage of the whole stay in Germany</li> <li>Region: Overseas, Europe and Germany must be covered</li> <li>Emergencies must be covered</li> <li>All medical expenses must be covered</li> <li>Health insurance with full coverage for sickness, emergencies and all medical expenses is absolutely mandatory for all exchange students in Germany. Students under the age of 30 can buy health insurance from a public German health insurance provider during Orientation (approx. 80 € per month).</li> </ul>
Cost of Living	<ul> <li>www.whu.edu/housingVallendar &gt; Cost of Living</li> <li>A student's cost of living will be approximately 800 euros per month, depending on their free time activities (e.g. travelling, eating out, using sports facilities, visiting concerts and clubs).</li> <li>Accommodation: between 335 € and 515 €</li> <li>Mobile Phone: 30 €</li> <li>Food: 150 €</li> <li>Local transportation: 85 € (monthly bus ticket)</li> <li>Health Insurance: approx. 80 € if acquired in Germany</li> <li>Miscellaneous (leisure activities): 300 €</li> </ul>
